Sri. Shiju Thomas, Pallivathukkal House, Chilavu P.O, Thodupuzha vide his application submitted through web site has sought Environmental Clearance under EIA notification, 2006 for the building stone quarry project in Survey Nos 294/1 pt, 294/2 pt, 295/5, 295/6 pt, 296/2 pt, 356/1-1 pt in Block 32 of Alakodu Village, Thodupuzha Taluk, Idukki Dist. for an area of 4.3049 hectares. The project falls under the category B2 as per the EIA notification No. S.O 1533 (t) dated. 14.09.2006 of MOEF & CC, other details of the project are as follows:-

1.About the project

Name of Project :- Building stone Quarry of Mr. Shiju Thomas, Pallivathukkal House, Chilavu P.O.

Brief description of the Project: The proposed rough stone quarry project is spread over an area of 4.3049 hectare, the proposed production is of 59510 m3 per annum and the span of the quarry is 5 years. The quarry operation is proposed up to 109 meter above MSL and to carry out with semi mechanized opencast mining with 5.0 meter vertical benches with a back width of 5.0 meter. Quarry operation is to carry out by splitting of rock mass from the permit rock area by jackhammer drilling and blasting. Hydraulic excavators are to use for loading the stone from pit head and tippers will be used for transportation of stones. Hydraulic excavators are intended to be attached with rock breakers for breaking of large boulders to avoid secondary blasting.

2. On submission of approved mining plan as per KMMC rule 2015,the proposal was placed in the first meeting of DEAC. Further to intimation of DEAC,the proponent along with the consultant attended the meeting. The DEAC decided to defer the item for field inspection and constituted a sub committee for the same. The sub committee inspected site on 25/01/2017 and put forward some conditions.

3. The conditions are as follows.

- The boundary pillars should be numbered and fixed in the lease area as per the approved mining plan
- Fencing with barbed wires should be provided all along the boundary of the lease area except the part needed for vehicular traffic.
- The boundary between the govt surplus land in survey no.356 on the southeastern side of the lease area and the applied lease area must be clearly demarcated.
- There should not be any further quarrying in the already quarried pit as the depth of pit has already reached more than 20 meters at present. The quarried pit should be retained as a rain water storing site.
- There should not be any further quarrying in the buffer zone area on the eastern side of the lease area where already quarrying was carried out as per the earlier permits
- A greenbelt should be maintained all around the quarry by planting trees.
- The ultimate depth of the quarry must be limited to 20 meter, from ground level as per the mining plan.
- There should be some rain harvesting structure at the north-eastern valley part of the quarry lease area
- The water draining from the quarry to the out side area must be after clearing the sediments and impurities by passing through one or two settling tanks
- Dust suppression mechanisms using sprinklers must be established in the quarry.
- · The approach road to the quarry must be tarred using metal.
- It is instructed to only remove topsoil up to a maximum depth of 2 meter while quarrying.
- **4.** In the 2nd meeting of DEIAA held on 30/03/2017, the committee after studying the case in detail accepted the 13 conditions raised by the DEAC. The committee also decided to collect the mining history of the proponent and authorized member secretary to collect it from district geologist. As decided by the Ist meeting of DEIAA, the documents of lands called for been submitted by the proponent and mining history of the proponent have been submitted by Senior Geologist, Mining and Geology Idukki District as reference (5). As per reference(5) it is found out that there are no charges were against the proponent for activities like illegal mining, mining outside the area and violation of lease permit to collect it from district geologist. Examining the details of land it is understood that the proposed site is a private land which is not assigned under any assignment rule of kerala but it is pandarayaka land as per the basic tax register. Land owners and the proponent has executed an agreement to excavate the granite building stone for the period of 15 years from the above mentioned area. Also going through the documents submitted by proponent such as detailed mining plan, mine closure plan, environment management plan and pollution control methods the committee is satisfied by the methods suggested there to reduce the gravity of pollution and steps to mitigate the risk of environment hazard. In addition to the above facts the committee analyzed the fact of severe shortage of granite building stone in the said region and its impact on social-economic condition of public and development of the region,the District Level Impact Assessment Authority Idukki hereby grant environmental clearance to the proposed quarry project Thomas pallivathukkal(h) chilavu in Thodupuzha taluk of Idukki district for an area of 4.3049 hectares subject to the condition specified in para 3

- 5. The clearance issued will also be subject to full and effective implementation of all the undertakings given in the application form, mitigation measures in the environment management plan of the pre-feasibility report and the mining features including progressive mine closure plan as submitted with the application and relied on for grant of this clearance. The undertaking and conditions regarding mining, blasting, pollution control and progressive mine closure plan of the mining plan submitted will be deemed to be part of this proceedings as condition as undertaken by the proponent, as if incorporated herein.
- **6.**Validity of the environmental clearance will be five years from the date of this environmental clearance, subject to the earlier review in the event of genuine complaint from anybody from the safety area or violation or non-compliance of any of the conditions stipulated herein.
- 7. Complaints of the conditions herein will be monitored by DEIAA and higher authorities of ministry of environment and forest government of India.
- (i) This E.C is one among the licenses to be obtained by proponent from mining. In order to start the mining activities and operations in the project the proponent must obtain the other licenses from the concerned authorities.
- (ii) Necessary assistance for entry and inspection should be provided by the project proponent and those who are engaged or entrusted by him to the staff for inspection or monitoring.

(iii) Instances of violation if any shall be reported to District collector, Idukki to take legal action under the environment protection act, 1986.






